## INSURANCE REQUIREMENTS / CORRECT WORDING FOR INSURANCE CERTIFICATE

- AppleBox Productions** must be named as "Additionally Insured" as well as "Loss Payee" for full replacement cost of the equipment being rented. Depreciated value coverage is not acceptable.
- The name of the insured must be the SAME name as of the Executive Producer and the equipment user of record.
- Date must be current.
- Limits: The dollar limit for rented equipment coverage needs to be at least equal to the value of the equipment being rented.

### **General Liability**

- Commercial General Liability
- Occurrence
- Limits: General Aggregate of no less than \$1,000,000

### **Automobile Liability** (Only required if client is renting a truck or generator)

- Hired Auto
- Non Owned Autos
- Limits: Combined Single Limit of no less than \$1,000,000  
Combined Single Limit for Bodily Injury and/or Property Damage- including Physical Damage. AppleBox Productions, Inc. shall be named as "LOSS PAYEE" under the Physical Damage coverage and both the vehicle (including equipment affixed thereto) and aggregate limit must be at Full Replacement Cost for the equipment and Actual Cash Value on vehicle. Lessee's evidence of insurance shall state that their coverage is Primary.

### **Other**

- Miscellaneous Equipment, In-land Marine, Property Damage

**The Deductible provision** of the above coverage must be within credit limits established by AppleBox Productions for the Lessee or a deposit may be required.

**DEFAULT AND BREACH OF TERMS:**

In the event that any of the payments hereunder become in default, or if you fail to perform any other provision of the Rental Contract, you agree that the Rental Company may file legal proceedings in any Superior or State Court, located in Duval County, Jacksonville, FL, and in the event that the Rental Company is the prevailing party in such action, you agree to pay all court costs, including reasonable attorney’s fees required to file any legal action to enforce any provision of the Rental Contract.

**ENTIRE AGREEMENT.**

The signed Credit Application and these Terms and Conditions constitute the entire agreement between you and the Rental Company. Any changes must be made in writing and agreed to by both parties.
